Commencement	2	These Rules shall come into force with immediate effect.
Amendment(s)	3 (i)	In Part-1, Chapter-3, Rule-7 after sub-rule (iv), sub-rule (v) shall be inserted as under: “(v) The counsel or party(ies) seeking an adjournment shall duly fill-in the adjournment slip in the prescribed format at Form-A1 with prior intimation to the opposite party(ies) or their counsel.”
	(ii)	An adjournment slip, appended to these amendment Rules, shall be incorporated as Form-A1, at the end of Chapter-3.
